

Harvesting Manager Job Description

TITLE

Harvesting Manager (HM)

REPORTING RESPONSIBILITIES

The HM is reporting to the Forestry Operations Manager (FOM) of GRL Tanzania

OBJECTIVE

The objective of the Harvesting Manager is to ensure maximum value and productivity is obtained from timber harvesting operations. The Harvesting Manager will focus on day-to-day management of harvesting crews in field as well as Safety, Health, Environment & Quality (SHEQ) and Production Conformances.

The Harvesting Manager will be based at GRL operations in Tanzania.

RESPONSIBILITIES

The responsibilities of the HM include:

- 1. Plan and coordinate timber harvesting operations in conjunction with the FOM, including site preparation, harvesting, and transportation of timber products.
- 2. Develop tactical harvesting plans that comply with company policies and procedures, ensuring adherence to FSC guidelines and principles.
- 3. Supervise harvesting crews and contractors to ensure work is performed safely, efficiently, and according to established guidelines.
- 4. Daily scheduling of trucks to relevant harvesting locations as well as coordination with roadside customers.
- 5. Monitor and evaluate harvesting operations to identify opportunities for improvement in productivity, cost-effectiveness, and sustainability.
- 6. Maintain daily, weekly and monthly accurate records of timber inventory, harvesting activities, and production volumes.
- 7. Report production daily to management as well as submit weekly inspection reports to ESG department.
- 8. Provide guidance and training to harvesting personnel in line with company's policies and procedures.
- 9. Conduct daily inspections of harvesting and transport operations to ensure compliance with safety and environmental procedures.
- 10. Any other responsibilities that may be assigned by management.

MANAGEMENT DUTIES

The HM will be responsible for all harvesting and transport operations within the GRL business unit.

- Technical Diploma or BSc in Forestry (or similar).
- 3 years + experience in forestry operations, with a focus on timber harvesting.
- Fluent in written and spoken English.
- High degree of integrity and honesty.
- Strong understanding of silviculture principles, and timber harvesting techniques. Knowledge of FSC audits is an advantage.
- Ability to work independently in challenging and dynamic environments.
- Ability to work under pressure.
